In addition, with the start of planting in the company's Uganda farm, the company is pleased to announce that it is currently working to certify its Uganda farm with the C.U.M.C. standard (as G.A.P.) and is undertaking this with assistance of representatives of the Peterson and Control Union.

According to a notification by the Tel Aviv Stock Exchange (TASE), the company is expected to enter the "Tamar" share reserve, which serves as a

base prior to entering the TASE indices. The reserve encompasses a list of all the shares that meet the basic threshold for being included in the TASE investment indices and includes more than 300 shares traded on the TASE. In addition, we will be able to save on third party production costs and we can make further savings by building the factory on the farmland itself."
